PURPOSE

Two students from each high school will be awarded \$1,000.00-\$4,000.00

(Depending on funding available. No award will be less than \$1,000.00)

CRITERIA

- Applicants must be completing their senior year at a high school in the tri-county UT area during the 2022-2023 school year
- Applicants must successfully graduate with a minimum GPA of 2.5
- Preference may be given to applicants who have participated in SWAT last year
- Applicants must agree to stay tobacco, alcohol, and drug-free
- Applicants must agree to meet the specified requirements

TIMELINE

- Recipients will be announced on ~~May 27th, 2022~~ July 1, 2022
- Scholarships will only be awarded to the chosen applicants who have met the specified requirements
- Scholarships will be awarded at the end of the 2022-2023 school year

2. One academic reference:
 - a. Advisor, guidance counselor, or teacher
 - b. Respected adult or community member
3. Completed essay
